The Information and Communication Technology Research group within New Brunswick Community College has obtained funding from the Advancing Accessibility Standards Research Program of Accessibility Standards Canada to conduct a three-year study of accessibility standards.

The purpose of this program is to support research that helps identify and remove barriers to accessibility. The program also seeks to fund projects aimed at preventing new barriers and that inform the development of next-generation model standards.

Our study will examine accessibility standards in three areas:

- Information and communication technologies,
- The built environment, and
- Transportation.

As part of this design process, NBCC-MU is conducting a series of surveys and interviews with individuals who have disabilities and people who care for people with disabilities.

You have a choice of two ways to participate:

- **Online interview** via videoconferencing.
- **Online survey** format.

Surveys and interviews last not more than 60 minutes.

Interview questions will be provided in a written format in-person and digitally before the interview.

You are eligible for this study if you answer "yes" to criteria 1 and 1 below and "yes" to at least one category under criterion 3 below:

1. You do not require a guardian to consent on your behalf.
2. You are at least 18 years of age.
3. You fit into one or multiple of the following categories:
 - 3.1. You are someone with disabilities. – Cohort 1
 - 3.2. You are someone experienced with accessibility (e.g. teacher, trainer, academic researcher). – Cohort 2
 - 3.3. You are someone who manages a disability program for an organization. – Cohort 3
 - 3.4. You care for someone with disabilities, including someone who has intellectual or cognitive impairments. – Cohort 4
